1. Journal

5. Fellowship:

Advertisements were inserted in the issues of the JISPE and on our Website calling for applications for grant of fellowship. However, the proposals received were either incomplete or not suitable to consider for fellowship.

As a part of the research project which was undertaken at the instance of the Azim Premji Foundation, Dr. Sharadini Rath had undertaken a lot of analysis of the secondary data compiled vide the recent Economic Census conducted in the year 2013. Shri Tilak informed the Council Members that Dr. Rath has forwarded a research proposal for the School's fellowship, wherein, she proposes to undertake a detailed analysis of the emergent patterns of concurrence between the industrial concentrations and the urban spread in and around those concentrations. Dr. Rath has proposed to undertake this exercise by juxtaposing the statistics compiled in the Economic Censuses, the Population Censuses as well as other data pertaining to industries that is available in other sources. The Council Members found this proposal acceptable and accordingly directed the Honorary Director to process Dr. Rath's proposal for the fellowship and complete all the necessary formalities for the award of the fellowship.
