1. Journal

2. Arthabodh Patrika

Launched in 1998, 'Arthabodhpatrika', the Marathi monthly of the School became a monthly publication with effect from 1 April 2003. During the period under review, in all 12 issues were published. A new schedule of the Annual Subscription charges has been introduced. The current number of subscribers stands at (650). Besides Shri Abhay G. Tilak who has been shouldering the responsibility of editing the magazine, Shri Parag Potdar has been associated with the publication in the capacity of an Associate Editor.

It has been realized that close to 300 institutions/individuals have not renewed their subscription. Efforts have been initiated to establish contacts with such institutions/individuals with a view to revive their membership.

The year 2019-20 was/ is the birth centenary year of Prof. V. M. 5. Fellowship:

No fresh fellowship was awarded during the year under consideration.

Dr. Sharadini Rath, Bangaluru was awarded a fellowship of the School during the financial year 2018-19. Out of the total sanctioned fellowship amount of Rs. 1.00 lakh, Rs. 25,000/-(Rupees Twenty Five Thousand only) has been released to Dr. Rath so far. According to the progress/status report furnished by Dr. Rath, the work on the assignment has been largely complete and the conclusion of the assignment is expected in a few weeks' time.

6. Research Projects

A research project was initiated in the month of June 2019 to prepare a sketch of a plethora of acts and legal provisions enacted by the State of Maharashtra having bearing on different facets on the incidence and spread of urbanization in the state. The exercise was undertaken with a

view to explore and understand the inherent linkage between the chronology, plausible logic and rationale behind enactment of laws as well as other legal instruments and the advance of urbanization in the State of Maharashtra. One research assistant was appointed for the study while the overall supervision vested with the Honorary Director. President of the School Prof. Sriraman and one of the Honorary Fellows viz. Dr. Ramanath Jha provided expert inputs and guidance over the course of the work. While the text of the write up was emerging, both Prof. Sriraman and Dr. Jha forwarded their observations and also suggested the direction for further analysis.

First draft of the write-up based on the analysis has been completed. The same is being reviewed by the Honorary Director. We look forward to publishing the piece in the Journal of the School subject to editorial approval.

8. Meetings:

The Annual Meeting of the Council was held on 15th of June 2019.

Three meetings of the Executive Committee were held during the period from 1st April 2019 to 31st March 2020, (i.e. 08/06/2019, 31/08/2019 and 21/02/2020).

9. Library:

The total number of books in the Library is 14,194 and that of documents is 5,434. During the year under report, 22 books were added to the stock, of which 9 books were purchased, 13 books were received as gifts, 36 documents were added to the stock. Out of the additions, 16 were regular documents, and 6 documents were received as gift; 14 CD downloaded at ISPE.

An amount of Rs.4,367/- was spent on purchase of books. In addition, an amount of Rs. 29929/- was spent as subscription towards periodicals and newspapers.

During the year under review, eight persons/students took the advantage of the reference material and reading facilities provided in the Library.

10. WEBSITE

The School has its own Website *ispepune.org.in*. A task of complete re-launch of the Website has been initiated with effect from December 2019. Services of M/s Vedbiz Technologies Pvt. Ltd., a Pune based software development concern have been hired for the same. After initial discussions with the engineers of the said firm, the actual work began in the second half of February 2020. However, due to subsequent lockdown the progress of the re-launch was

disrupted till August 2020. As of now, a large part of the assignment is over and we hope to launch the improvised Website of the School towards middle of October 2020.
