# INDIAN SCHOOL OF POLITICAL ECONOMY, PUNE



#### 1. Journal

One joint issue for January-June 2008 and two single issues for July-September and for October-December 2008 of the *Journal of Indian School of Political Economy*,

containing research articles on various themes, including papers on Cast Dynamics and Political Process in Bihar along with Observations on Selected Cross Tabulations of Lok Sabha Election (2004) Post-Poll Sample Survey of Voters from Bihar, Economic Survey 2009-10, Government of Bihar, Statistical Supplement on Lok Sabha Election, 2004, All-India Party-wise Performance, The Performance of Indian Iron and Steel Industry and Competitiveness of the Firms, Interpreting the Relation of Money, Output and Prices in India (1991:2008), Land Use Pattern in Indian and Pakistan Punjab.In October-December 2008 issue contained paper entitled 'Development of Social Science Research : Some Neglected Dimentions' by Professor V. M. Rao and The issue 1 for 2008 is almost complete and expected to be published by the end of May 2010.

The flow of articles for the delimited fields of the Journal was more or less adequate, resulting in delay in the publication of the journal.

The Journal has been publishing the contents pages of sister quarterlies on an exchange basis.

The total number of subscribers for 2008 stood at 123, 2009 at 82 and 2010 at 36 while 21 copies are being sent as gratis or on exchange basis. The subscription is expected to grow as we start publishing issues of the journal and the subscription rates continued to be:

#### 2. Arthabodh Patrika

*Arthabodh Patrika'*, the original bi-monthly periodical of the School, launched in 1998 in Marathi, completed 11 years in November 2009. It became monthly publication with effect from April 2003 issue.

**Number of issues published -** Twelve (Volume 8, issues 1 to 12). Of these five were Special Issues contained focused articles on subjects such as global recession, environmental degradation, political party system in India, food culture and eating habits, food security, science and scientific research. Together 432 pages of reading material.

Besides this, 24 books on a variety of subjects and study reports available in the ISPE library as also 33 different Websites.

One of the purposes of the Patrika is to encourage newspapers and other periodicals to reproduce articles from the Patrika free of cost, after acknowledging the source. It is, however, difficult to judge the exact impact as all the periodicals, which reproduce the articles in their issues, do not send copies of their publications to us as expected of them.

At the end of March 2010 the total number of subscribers to the Patrika stood at 411. Special efforts will be made to enroll more direct subscribers during the coming financial year.

#### **WEBSITE**

The School has recently launched its own Website and the address is *ispepune.org.in*. The website contains back issues of the Journal of Indian School of Political Economy from the year 2000 onwards as also that of *Arthabodhpatrika* from January 2007 onwards. #### 3. Books and Booklets

A publication based on the Study of Primary Schools conducted by Pune Municipal Corporation, being carried out by the School is expected to be published in Marathi in 2010-11.

# 5. Fellowship:

Retired Justice Narendra Chpalgaonkar has completed his project on the work of the three Justices and submitted the final chapters. The Marathi version of the study is expected to be published shortly with Mauj Prakashan as co-publisher. The same has been translated in English from Marathi for publication in the form of a book.

# 6. Research Project on the Primary Schools of Pune Municipal Corporation

The School has undertaken a research project on the primary schools conducted by the Pune Municipal Corporation. The study has been initiated with effect from September 2005 after receiving the permission of the Pune Municipal Corporation (PMC) and the Municipal Education Board for accessing the relevant original records of the PMC and for administering the proposed tests to the sample students. The twin objectives of the said study are:

- To record, analyse and study the trend of enrolment in every class in all types of schools during the last thirty years.
- To investigate the level of education at the primary level. This inquiry would involve understanding of aspects such as students' ability in reading, writing and arithmetic.

A Seminar based on the reports of the Associate Researchers was held on July 30-31, 2008 and detailed deliberations were held. Based on the same, a draft of the Final Report had been submitted by the Associate Researchers. The draft of the chapter on Arithmetic and the revised draft on the chapter on language teaching were received in the School during the absence of the Hon. Director in the USA. Shri Abhay Tilak and the President read the drafts. Both of them came to the conclusion that it would not be useful to ask for further revision of the drafts. Instead, they agreed that Shri Tilak shall do the work of revising the drafts for publication. Shri Tilak is at it and expects to complete the revision by the end of March 2010.

# 8. Meetings:

The Annual Meeting of the Council was held on 6th June 2009 and one resolution was passed by circular meeting.

# 9. Library:

The total number of books in the Library is 13,130 and that of serials is 3,706. During the year under report, 324 books and 107 serials were added to the stock. Out of the additions, 5 books and 29 serials were received as gift; while 9 books were received for

review, 310 books and 66 documents were purchased and 7 were subscribed to. The Library also acquired Databases in CD form on the Census 2001.

An amount of Rs.1,44,120 was spent on purchase of books. In addition, an amount of Rs.900/- was spent as subscription towards periodicals.

During the year under review, 41 persons/students took the advantage of the reference material and reading facilities provided in the Library.

#### Research work in hand

I am preparing a monograph on the impact of the global recession on economic thinking and policy making in the broad. The Great Depression of the 1930s is linked directly or indirectly with rise of fascism, the second world war, the welfare state and much else that affected the relative roles of the Market and the State in economic theory and practice. The Crisis of 2008-09 is rated as second in intensity to the Great Depression. In the trough of the recent crisis, many economists in the academia and the media speculated on the future of capitalism particularly in its globalized version. Some radical economists shed their gloom at the fall of communism and celebrated the Crisis as the triumph of Marxian economics over the mainstream micro- and macro- economics. I plan to present the denouement in simple English first and try to translate it in Marathi later.

In the last eight months despite many interuuptions I have written first drafts of five sections of the ten I visualize for the monograph.
